Advocacy Activities:

Advocacy has been a central part of NMAEYC's mission since its inception, 54 years ago. NMAEYC is a grassroots association with 870+ members statewide; it plays a key role in connecting the field of early childhood with policy issues and policy makers. Advocacy and policy maker education are essential strategies that NMAEYC uses to promote its mission: access for ALL children to high quality early childhood education. NMAEYC's advocacy work included taking a lead in organizing statewide Early Childhood Public Policy trainings in order to train the community on advocating at both the state and national level for childcare stabilization, and increased wages for the early childhood workforce. NMAEYC took part in shaping early childhood legislation, tracking bills and issues and informing the broader early childhood community about what was going on and when and how to make their voices heard.

The work of NMAEYC continues to find ways to connect the early childhood community to advocacy for early care and education. This is done through organizing public policy events around the state, participating in community events and legislative meetings, and writing reports. NMAEYC's has been supported by both the National Association for the Education of Young Children (NAEYC) as well as local NM Foundations: the Thornburg Foundation, LANL Foundation and the Brindle Foundation. Our advocacy work promotes discussion and consensus building around the definition, accountability, qualifications and compensation of the early childhood education profession.

Our professional development trainings have significantly grown. NMAEYC has administered over 2000 continuing education scholarships to early childhood

professionals and deepened its reach in every part of the state. These ongoing

internal capacity building efforts should assist the organization to develop a strong public policy initiative and activate its membership while diversifying its financial base of support. Diversifying its funding sources should also provide the organization greater financial capacity across various programs. Continued strategic communications ability and flexible funding will position NMAEYC to leverage its valuable asset of a diverse statewide membership of early childhood professionals toward achieving a full spectrum of high quality early childhood programming available to every family who wants it. Due to COVID, our 2021 conference included a hybrid format - a full day preconference, in-person and held outdoors in a nature setting in order to comply with state COVID rules. NMAEYC AFP Supports programs through Training on NAEYC Accreditation and Standards as Best Practices, onsite as requested by individual programs (accredited and non-accredited), during the NMAEYC annual conference and in other NMAEYC sponsored PD gathers and ECE settings.
